Privacy Policy & Cookies

Testenium believes the efficient collection, use and transfer of information must be handled in a lawful, fair and responsible manner. This policy sets out openly the ways in which we may collect and process personal data relating when you do business with us.

Providing and Processing your personal data

By visiting our website you provide no personal data. However, when you register with us as a customer you will provide personal data, that is, your name postal and email, address and telephone number. If you buy our services, you will pay either by PayPal, or by providing credit cards and bank account details, so that you will be charged on account.

We process this data by using it only for the usage of Testenium platform and services. It will not be used for any other purpose

If you apply for employment with us you will submit an application setting out your date of birth, education and work history, address, email and postal, and telephone numbers, and at our request details of referees . If you are employed by us you will provide your P45, and bank account details for the purpose of paying your salary.

If you thereafter suffer from ill-health, you may be required by the terms of your employment contract to provide medical details of your condition and the name and address of your doctor.

How long do we keep your data?

We will keep your personal data for as long as our contractual and/or business relationship lasts. We may then place your personal data in a secure intermediary database for seven (7) years after our contractual and or business relationship expires, to be accessed only for tax or regulatory purposes, or as may be required by law.

If you are a prospective customer or employees, but do not enter into any relationship with us, we will maintain your date in this secure database for two year for legal and regulatory purposes. with no established contractual and/or business relationship, we will not keep your data for longer than three and a half (3.5) years after you last contacted us.

you shared with us at the latest two (2) years after you shared the information.

We may retain information collected by the use of our platform for recording the frequency and scale of your use for accounting purposes for not more than one year after collection.

Sharing your Personal Data

1. With other entities of the group

Testenium is a global organisation. We expect that we shall soon have distinct legal entities in other countries. We may share your personal data with them, inside and outside the EU. if the efficiency of data access and management requires the keeping of data in different locations.

2. Judicial, public and/or governmental authorities

We may also be required by law, such as by requirements by made public and governmental authorities, within or outside your country of residence, to disclose your personal data to them. We shall inform you if we are required to supply such data, unless we are forbidden by law to do so,

We may also disclose your personal information if we determine in good faith that disclosure is reasonably necessary to protect our rights and to pursue available remedies, enforce our terms and conditions, investigate fraud, or protect our operations or users from unlawful attack.

Business reorganisations

Like many organisations, Testenium may reorganise its business operations around the world from time to time, whether by buying new businesses or selling or merging existing businesses. This may involve disclosure by us of personal data to prospective or actual purchasers of parts of our business, or receiving personal data from potential sellers. It is our practice to require appropriate confidentiality protection for personal data disclosed in these types of transactions.

Your rights

Cookies
